Regarding the subject above, I have the honour to inform you that, on the 15th October 2021, Australia notified the Government of the Portuguese Republic, in its capacity as Depository of the Energy Charter Treaty, of its intention not to become a Contracting Party to the Energy Charter Treaty and to the Energy

Charter Protocol on Energy Efficiency and Related Environment Aspects, both signed in Lisbon, on the 17th December 1994.

Australia further declared that it does not consider itself bound, provisionally or otherwise, by any provision of the Energy Charter Treaty upon the expiration of 60 days from the date on which this notification is received by the Depositary.

Under Article 45, paragraph 2, subparagraph c) and Article 45, paragraph 3, subparagraph a), the termination of provisional application for Australia shall take effect on the 13th of December of 2021.


